Plan Descriptions

A description of how parents, teachers, and school staff were involved in the development of the plan.

Results from the parent interest survey that offered learning loss recovery showed that parents are highly interested in extended learning opportunities for their children. From the interest survey, stakeholders were asked to provide anecdotal and data based findings on needs assessed during the 20-21 school year.

The decision to present the program to teachers and administrators was based upon collaboration with the school district. Teacher's input resulted in the outsourcing of a third party educational program for the after school sessions, so teachers did not feel pressured to extend their work days.

Previous years of summer school were provided for Riverside Preparatory Elementary students for enrichment. This year, Riverside Preparatory is expanding the summer school offering to include learning loss, social and emotional wellness, and re engagement and credit recovery.

This expanded learning program is open to all Riverside Preparatory students. If the participation in the program is too great for what the school can accommodate, focus will be given to unduplicated student populations. Riverside Preparatory has hopes that most of its students will participate in the program and is preparing to offer the programs to as many students as possible.

Riverside Preparatory gauged interest in the summer school and after school programs through an online interest survey. Site administrators also communicated with teachers and families. General announcements will go out about the program through traditional school methods such as all-call, peachjar and facebook. Parents are encouraged to participate in School Site Council meetings, DELAC and site based meetings. These meetings will allow parents to give input on instructional support and also receive information on the progression and effectiveness of programs throughout the school year.

A description of the LEA's plan to provide supplemental instruction and support.

Students will be meeting individually with staff assigned to them over the summer. Staff will check in weekly with students to foster social emotional wellness, and encourage engagement and return to learning. The staff will be compensated in the form of a 5% bonus for this extra work.

The summer school program offered by Riverside Preparatory this year will center around student reengagement, the social norms of being physically back in school and relationship building. The program will provide the same services that students receive in a normal school year, nutrition services, health services, transportation access, counseling and social emotional education.

Professional Development will be provided for all teachers in extended learning. The focus of the Professional Development will include spiraling and articulation of standards across grade levels so that each teacher can help students overcome learning loss in the covid school year, and accelerate/enrich learning for students who are achieving academically at higher rates. The teachers will also focus on modifying scopes and sequences to adjust for the loss and enrichment. Teachers will also receive support in data collection and analysis to support learning loss results.

Riverside Preparatory will be expanding a partnership with iSchool a program that focuses on hands-on experiential learning.

In the 21-22, school year, Riverside Preparatory will be launching the ECA+ (Early College Admission) program. These students will be invited to an expansion over the summer bridge into the program. Book club/ nonfiction reading with the students in the program and then Social Emotional Learning. The program is also being offered to other 8th graders based on an interest survey. The teachers will extend the learning MWF two weeks in the summer. This offering is unique to these students for enrichment and social emotional learning.

Extended Learning throughout the 21-22 school year will be provided by a third party afterschool program that will be housed on campus for Oro Grande Students. The school will provide transportation for students willing to participate.

In-Person Instruction: \$827,019

*\$827,019 to pay for extra teachers during in-person instruction. They helped reduce class sizes, which provided social distancing. This expense was funded in the 2020-2021 school year.

- English learners,
- foster youth,
- homeless students,
- students with disabilities,
- students at risk of abuse, neglect, or exploitation,
- disengaged students, and

For purposes of this requirement

- "Supplemental instruction" means the instructional programs provided in addition to and complementary to the LEAs regular instructional programs, including services provided in accordance with an individualized education program (IEP).
- "Support" means interventions provided as a supplement to those regularly provided by the LEA, including services provided in
 accordance with an IEP, that are designed to meet students' needs for behavioral, social, emotional, and other integrated student
 supports, in order to enable students to engage in, and benefit from, the supplemental instruction being provided.

• "Students at risk of abuse, neglect, or exploitation" means students who are identified as being at risk of abuse, neglect, or exploitation in a written referral from a legal, medical, or social service agency, or emergency shelter.

EC Section 43522(b) identifies the seven supplemental instruction and support strategies listed below as the strategies that may be supported with ELO Grant funds and requires the LEA to use the funding only for any of these purposes. LEAs are not required to implement each supplemental instruction and support strategy; rather LEAs are to work collaboratively with their community partners to identify the supplemental instruction and support strategies that will be implemented. LEAs are encouraged to engage, plan, and collaborate on program operation with community partners and expanded learning programs, and to leverage existing behavioral health partnerships and Medi-Cal billing options in the design and implementation of the supplemental instruction and support strategies being provided (EC Section 43522[h]).

The seven supplemental instruction and support strategies are:

- 1. Extending instructional learning time in addition to what is required for the school year by increasing the number of instructional days or minutes provided during the school year, providing summer school or intersessional instructional programs, or taking any other action that increases the amount of instructional time or services provided to students based on their learning needs.
- 2. Accelerating progress to close learning gaps through the implementation, expansion, or enhancement of learning supports including, but not limited to, any of the following:
 - a. Tutoring or other one-on-one or small group learning supports provided by certificated or classified staff.
 - b. Learning recovery programs and materials designed to accelerate student academic proficiency or English language proficiency, or both.
 - c. Educator training, for both certificated and classified staff, in accelerated learning strategies and effectively addressing learning gaps, including training in facilitating quality and engaging learning opportunities for all students.
- 3. Integrated student supports to address other barriers to learning, such as the provision of health, counseling, or mental health services, access to school meal programs, before and after school programs, or programs to address student trauma and social-emotional learning, or referrals for support for family or student needs.
- 4. Community learning hubs that provide students with access to technology, high-speed internet, and other academic supports.
- 5. Supports for credit deficient students to complete graduation or grade promotion requirements and to increase or improve students' college eligibility.
- 6. Additional academic services for students, such as diagnostic, progress monitoring, and benchmark assessments of student learning.
- 7. Training for school staff on strategies, including trauma-informed practices, to engage students and families in addressing students' social-emotional health needs and academic needs.

As a reminder, EC Section 43522(g) requires that all services delivered to students with disabilities be delivered in accordance with an applicable IEP.

Fiscal Requirements

The following fiscal requirements are requirements of the ELO grant, but they are not addressed in this plan. Adherence to these requirements will be monitored through the annual audit process.

- The LEA must use at least 85 percent (85%) of its apportionment for expenditures related to providing in-person services in any of the seven purposes described above.
- The LEA must use at least 10 percent (10%) of the funding that is received based on LCFF entitlement to hire paraprofessionals to provide supplemental instruction and support through the duration of this program, with a priority for full-time paraprofessionals. The supplemental instruction and support provided by the paraprofessionals must be prioritized for English learners and students with disabilities. Funds expended to hire paraprofessionals count towards the LEAs requirement to spend at least 85% of its apportionment to provide in-person services.
- An LEA may use up to 15 percent (15%) of its apportionment to increase or improve services for students participating in distance learning or to support activities intended to prepare the LEA for in-person instruction, before in-person instructional services are offered.
